Name of Corporation:

Morris Land Trust

- 2. C. The Corporation shall have one class of members.
- 5. Other information:

The corporation shall exist perpetually.

The class, rights, privileges, qualifications, obligations, and the manner of election or appointment of officers and directors are set forth in the By-Laws of Morris Land Trust.

The property of this corporation is irrevocably dedicated to charitable purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member, if any, of this corporation, or any other private person. Upon the winding up and dissolution of this corporation and after paying or adequately providing for the debts and obligations of this corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and that has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
